Hatem-Roy receives national leadership award



On Monday, Elder Services' CEO Joan Hatem-Roy was awarded the Excellence in Leadership Award by the National Association of Area Agencies on Aging (n4a) during its annual conference.

The award is given to Area Agency on Aging (AAA) and Title VI directors across the country who have demonstrated exceptional leadership capabilities at the local, state, or national level in advancing the mission of the Older Americans Act and preparing communities for our nation's rapidly aging population, according to n4a.

"So many of us have been working under challenging circumstances this past year, and I am so humbled to be recognized," Hatem-Roy said. "This award represents the staff, board of directors and countless donors, partners, and volunteers who work tirelessly for our mission."

As CEO, Hatem-Roy leads the largest AAA in New England, serving more than 40,000 individuals annually. During the past three years, she has

navigated the agency through a natural gas explosion that devastated three communities we serve; a merger with a neighboring agency, North Shore Elder Services; and the COVID-19 pandemic.

CareRide celebrates 2nd anniversary of success



This popular program provides on-demand transportation to doctors' appointments and health and wellness activities when other options aren't available. Since 2019, [CareRide](#) has helped more than 2,000 people access the health care they need, like Frank, a Lowell resident who couldn't have gotten to his chemotherapy treatments in Boston without it.

The subsidized ride program uses Lyft and handicap-accessible vans to accommodate people age 65 and older in the towns of Billerica, Chelmsford, Dracut, Dunstable, Lowell, Tewksbury, Tyngsboro, and Westford. Elder Services employee testifies in support of Personal Care Homes legislation for seniors




On July 12, Elder Services provided testimony to the Joint Committee on Elder Affairs during a virtual hearing. Robyn Nathan, one of our Supportive Living Services employees, spoke to lawmakers about [S418/H745](#), an Act to Establish Personal Care Homes for Older Adults. Robyn, who has worked in our Danvers office for more than 30 years, was pivotal in establishing the pilot version of these Personal Care Homes in 2006. Nine states already license such homes.

This bill would authorize a new model of housing and support for older adults who need significant care and assistance but who wish to remain living in the community:

- These homes are developed to enable groups of 4 to 6 unrelated individuals to reside together in one home where every resident has a private bedroom and the common areas are shared.
- Home care staff are assigned to the home to provide direct care services and assist residents with their daily long-term services and needs, including meal preparation, shopping, laundry, and personal care.

The bill is sponsored by [Senator Joan Lovely](#) and [Representative Sally Kerans](#), who have been strong advocates for ESMV-NS and older adults.
